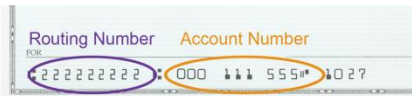

INDIVIDUAL & GROUP MEMBERSHIP TERMS AND CONDITIONS OF MEMBERSHIP

The following Terms and Conditions shall apply to all Memberships issued by Sacramento Gun Club, LLC (“SGC”) for membership in Sacramento Gun Club, LLC. Any reference to “you” or “your” shall refer to the Primary Member identified on the Membership Application and Agreement (the “Application”) for such Membership. Any reference to “Group members” shall mean the additional members entitled to membership benefits under a Group Membership, as set forth herein. Any reference to “Members” shall mean the Primary Member and any additional members entitled to membership benefits under the Group Membership.

1. **MEMBERSHIP REQUIREMENTS.** No Application for membership shall be effective until: (a) the Application is completed and signed by the Primary Member and submitted to “SGC” with the required Initiation Fee, (b) the first month’s pro-rata dues are paid in full, (c) a Payment Authorization is signed and delivered to “SGC” providing for payment of the monthly Membership dues, (d) the Application is approved and accepted by “SGC”. “SGC” reserves the right to approve or reject any Membership Application.
2. **MEMBER’S RIGHT TO CANCEL.** You may cancel the Membership at any time by sending **an e-mail notice to membership@sacramentogunclub.com** as provided herein. If the notice is received on or before the 10th day of any month, the cancellation shall be effective as of the last day of such month. If the notice is received after the 10th day of any month, the cancellation shall be effective on the last day of the next month. The initiation fee and any prepaid monthly dues shall be earned in full upon receipt and shall be non-refundable in the event of your cancellation of the Membership or termination of the Membership by “SGC” for any reason.
3. **“SGC’S” RIGHT TO TERMINATE.** “SGC” may terminate your Membership at any time for failure to pay the applicable Membership dues or following any breach or violation of these Terms and Conditions or other Rules of the Club by you or any of your group members or guests, or for any conduct which, in the opinion of management of “SGC” in its sole discretion, is prejudicial to the welfare, good order, and character of the Club, by sending written notice to you.
4. **CHANGES IN THE TERMS AND CONDITIONS OF MEMBERSHIP.** “SGC” reserves the right, in its sole discretion, to discontinue operation of the Club or to modify these Terms and Conditions of Membership, to sell, lease or otherwise dispose of the Club facilities in any manner whatsoever and to any person whomsoever, to add, issue, modify, or terminate any category of Membership, to discontinue operation of the Club facilities, to limit use of the Club facilities, to convert the Club into a member-owned club, and to make any changes to the Membership benefits at any time. Such changes shall be effective on the date such revised Terms and Conditions of Membership are posted to the “SGC” web-site or as otherwise communicated to the Members. Any such changes shall be binding on you on the effective date of the change.
5. **CHANGES IN THE MEMBERSHIP BENEFITS.** “SGC” reserves the right to add, eliminate or change any published Membership benefit or amenity at any time and from time to time, in its sole discretion. The Membership benefits at any time shall be as posted on “SGC’s” web-site or as otherwise communicated to the Members. Such changes shall be effective on the date such revised Membership benefits are posted to the web-site or communicated to the Members.
6. **GROUP MEMBERSHIPS.** A Group Membership shall grant membership privileges to the Primary Member identified on the Application and **up to three additional members.** All additional members shall be required to meet the same conditions of membership and shall have the same privileges as the Primary Member.
7. **PAYMENT OF DUES; OTHER CHARGES.** Monthly dues shall be due and payable on the first day of each month. The initial monthly dues shall be as set forth on the Application. **The monthly membership dues may be increased at any time upon 30 days prior written notice to you by “SGC.”** “SGC” may also change any other charges applicable to services provided to Members at any time. Monthly dues are required to be paid by a monthly charge to your ACH debit on your bank account or by credit card. Payment terms will be set forth in the Payment Authorization executed by you and delivered to “SGC” with the Application. You may change the terms of the Payment Authorization by submitting a new Payment Authorization to “SGC” at least 30 days in advance of the next payment due date. It is the Member’s responsibility to make sure a valid Payment Authorization is on file at all times, and that a new Payment Authorization is submitted any time the applicable bank account information is changed. Notwithstanding the foregoing, you may, at your option, pay Membership dues for any 12 month period in advance.
8. **LATE CHARGES.** It is your responsibility to ensure that the method of payment set forth in the most recent Payment Authorization provided to “SGC” remains a valid method of payment. In the event of a cancellation or change in the account information associated with any bank account, you must provide a new Payment Authorization by e-mail (**membership@sacramentogunclub.com**) no less than 15 days prior to the next payment due date. In the event any ACH charge

is declined or returned, you will be responsible for a processing fee of \$35.00 in addition to payment of the unpaid dues, for each month that the dues are not paid pursuant to a new Payment Authorization. In addition to the processing fee for any payment that is declined or returned, "SGC" reserves the right to immediately limit or terminate any or all Membership privileges on any delinquent Memberships.

9. CLUB AND RANGE RULES. "SGC" may establish rules, regulations and policies concerning the operation of the Club and Range (the "Rules") from time to time. The Rules and all changes thereto shall be provided to the Members and shall be posted on the web-site. You acknowledge and agree to follow the Rules at all times, and insure that your guests and family members follow such rules. Any violation of the Rules by you or your guests or group members shall be grounds for immediate suspension or termination of all of a portion of your Membership privileges.
10. GUEST POLICY. An Individual Membership shall only cover Membership privileges for the Primary Member. A Group Membership shall only cover Membership privileges for the Primary Member and the qualifying group members as set forth herein who are approved by "SGC". Any other persons accompanying a Member in the VIP Lounge or Range shall be considered a guest. Each Member may be granted a number of Guest Passes as a benefit of Membership, as set forth from time to time on the "SGC" web-site. You are responsible for supervising your guests at all times they are on the "SGC" premises, and for any damages to the premises or Range caused by your guests.
11. USE OF CLUB FACILITIES. You acknowledge and agree that the VIP Lounge and Range are not provided for the exclusive use of the Club Members and their guests. From time to time, "SGC" may host internal Club events, manufacturer promotions, private rentals, marketing and other events in the VIP Lounge and Range during and after normal business hours of the Range. All such events and any scheduled maintenance requiring closure of the VIP Lounge or Range shall be communicated to the Members in advance by e-mail and/or by posting on the Club bulletin board.
12. LIABILITY AND WAIVER OF LIABILITY. The Primary Member shall be financially responsible and liable for any property damage resulting from the acts or omissions of such Member, their group or guests on the "SGC" premises, including damage resulting from shooting the target carrier (intentionally or unintentionally) or damage to any furniture or furnishings in the VIP Lounge. You are fully responsible for the loss or theft of, or damage to, any firearms or other personal property you bring to the VIP Lounge or Range, or store in a rental locker in the VIP Lounge or leave in your automobile on the "SGC" premises. You hereby release and hold harmless "SGC", its affiliate, and each of their respective members, managers, officers, employees, and agents (the "SGC Affiliates"), from and against any claim arising out of or relating to the loss or theft of, or damage to, any such property and any claim for bodily injury arising out of the use of the Premises by you, your group members and guests. In no event will any "SGC Affiliates" have liability for any indirect, incidental, special, consequential or punitive damage, even if advised of the possibility of such damages.
13. INDEMNITY. By execution of the Application and use of "SGC" facilities, you agree to defend, indemnify and hold harmless the "SGC Affiliates" from and against any claims, lawsuits, damages, liabilities, expenses or costs the "SGC Affiliates" may incur, including attorney's fees of counsel acceptable to "SGC" ("Claims and Damages"), arising out of or resulting from the acts or omissions of you, your group members or guests. Moreover, you agree to defend, indemnify and hold harmless the "SGC Affiliates" from and against any Claims and Damages arising out of or resulting from claims asserted against "SGC Affiliates" by your group members and/or guests.
14. ASSUMPTION OF THE RISK. You acknowledge and agree that the indoor firing range operated by "SGC" involves the use and discharge by you and others of pistols, rifles, shotguns, and other weapons, which are potentially dangerous activities. You acknowledge and agree that those activities involve certain risks and exposure to bodily injury or death, which risks and exposure you voluntarily assume by becoming a Member of "SGC" and using its facilities. In consideration of the use of "SGC" facilities by you, your group members and guests, you hereby accept and assume full responsibility for any and all injuries, losses or damages sustained or incurred by you, your group or guests resulting from or arising out of any activity or event occurring on the "SGC" premises, and release in full and forever discharge the "SGC Affiliates", whether acting officially or otherwise, on behalf of yourself, your group members, your guests, your heirs, executors, administrators and personal representatives, from and against any and all claims, demands, or causes of action for any injury, death, property damage, loss, claim, or liability resulting from or arising out of any activity or event occurring on the "SGC" premises.
15. COMMUNICATION AND NOTICES. All communications between you and "SGC" shall be by e-mail or personal delivery. Accordingly, as a condition to your Membership, you are required to maintain a valid e-mail account at all times. Any failure to maintain a valid e-mail account shall be grounds for termination of your Membership. The e-mail address of the Primary Member as set forth on the Application or the e-mail address registered with "SGC" for purposes of "SGC'S" mailing list subscription shall be used by "SGC" to communicate with you. Any of your correspondence or notices required hereunder shall be sent to **membership@sacramentogunclub.com**. Either party may change the e-mail address for communication purposes hereunder by sending a change of address notice to the other party in accordance with the terms of this paragraph.
16. MISCELLANEOUS.
 - a. The types of memberships available, applicable fees, suspension or expulsion of Members and all other matters affecting or relating to the Members or the Membership shall be at the sole discretion and control of "SGC."
 - b. It is the policy of "SGC" to accept applications for Membership from any individual, group, facility or business that meets the requirements established from time to time by "SGC", without regard to race, color, creed, gender, religion or national origin, nor shall such matters ever be made a condition of Membership.
 - c. The Membership is personal to the Primary Member and may not be transferred or assigned at any time to any other person. In the event of the death of the Primary Member, the surviving spouse of such Member, if any, may continue as the Primary Member for the Membership without paying any additional Membership Fee. In the event the deceased Member is not survived by a spouse or the spouse does not

desire to continue the Membership, it shall be terminated, unless it is a group membership and another member of the group elects to accept and become the Primary Member. In the event the Primary Member becomes legally separated or divorced, ownership of the Membership shall continue with the Primary Member unless and until the Membership is awarded to the spouse by written agreement or final divorce decree, and "SGC" is given written notice thereof.

- d. You acknowledge that there have been no promises, warranties or representations, express or implied, pertaining directly or indirectly to the Membership which are not contained herein, in the Application or on the "SGC" web-site.
 - e. In any dispute relating to non-payment of dues or charges for damage to the premises or personal property by you, your group or guests, you shall be responsible for any attorneys' fees' and/or costs incurred by "SGC" in enforcing its rights under these Terms and Conditions.
 - f. Any waiver by "SGC" of any right or obligation hereunder shall be deemed a continuing waiver and no failure by "SGC" to exercise, in whole or in part, any rights provided to "SGC" hereunder shall prevent the later exercise of such right or any other right. No waiver by "SGC" shall be effective unless such waiver is in writing and signed by "SGC."
 - g. The invalidity or unenforceability of any term or provision of this Agreement shall not affect the validity or enforceability of the remaining terms or provisions hereof, which remaining terms and provisions shall remain unmodified and in full force and effect.
 - h. The rights and obligations of the parties arising out of the Membership, including the terms and conditions set forth herein, as amended from time to time, shall be governed by the laws of the State of California.
 - i. Membership is not considered ownership in any percentage of the range.
17. TRANSPORTATION OF FIREARMS. All firearms in the member's possession being transported to and from the premises must be unloaded and kept in a locked container.

The Undersigned thereby acknowledges and agrees to have voluntarily applied to use the shooting range and Facilities operated by Sacramento Gun Club, LLC. It is understood and acknowledged that the use of a shooting range in which others, as well as the Undersigned, are engaged in shooting activities inherent extreme hazards, dangers, and risks. The Undersigned represents that he/she is fully competent to participate in training and shooting activities and that he/she freely, knowingly, and voluntarily assumes the risks of participating in such activities, including the risks of property damage, bodily harm, and death.

The Undersigned acknowledges, understands, and will follow the posted and printed Range Safety Rules. The Undersigned further acknowledges and fully understands that failure to follow the posted and printed rules will result in immediate expulsion from the range.

By signing this instrument, the Undersigned affirms that he/she has read, understands, and will comply with the requirements as set for herein, and do hereby agree to defend, indemnify, and hold harmless Sacramento Gun Club, LLC, and its officers, directors, owners, partners, agents, brokers, employees, insurers, assigns, administrators, assignees or heirs, and all other related person, entities, affiliates, predecessors, and successors, from any act or omission for which the Undersigned is directly responsible.

Range Safety Rules

1. Everyone who is using the range, regardless of experience, must first go through the range safety orientation and complete all required paperwork. No exceptions.
2. The use of alcohol and drugs before or during shooting is prohibited.
3. No food, drink, chewing gum or tobacco products are allowed on the range.
4. Eye and ear protection **MUST** be put on before entering the range and must remain on during the entire use of the range.
5. All firearms must be unloaded, cased and locked while going to and from the range. Law Enforcement and Concealed Carry Permit holders are allowed to enter the facility holstered and hot. The range requests to see your CCW permit or law enforcement identification. For safety reasons loaded firearms are prohibited in certain areas of the facility where dry fire exercises may take place. These areas include all classrooms, as well as the simulator room.
6. Shooters must remain behind the firing line at all times during open shooting hours.
7. Firearms and ammunition used on the range may be subject to inspection at any time. ***Class III firearms must be accompanied with proper paperwork.***
8. Firearms may be un-cased or un-holstered within the confines of the shooting booth **ONLY**. All firearm handling is restricted to the confines of the shooting booth. **Never handle firearms outside the shooting booth area.**
9. Always keep firearms pointed in a safe direction while on the range. This means downrange.
10. Always keep your finger off the trigger until your firearm is pointed at the target and you are ready to shoot.
11. All targets must be placed at eye level to ensure the rounds go directly into the backstop. Be mindful of range damage, bullets do continue on a path beyond the paper and cardboard targets you are shooting at.
12. Only aimed fire is allowed on the range. This means firearms must be sighted at eye level. Shooting from the hip is specifically prohibited.
13. Firearms may only be tabled unloaded with the actions open and muzzle pointed downrange. For revolvers this means cylinder open and visible, muzzle pointing downrange. For semi-automatics this means slide locked to the rear, magazine removed, ejection port facing up and muzzle pointing downrange. The only exception is during a cease-fire.
14. If you have brought more than one firearm, use only one at a time. When finished with one, lock the cleared firearm and ammunition in the case before moving on to use the next one.
15. Drawing from concealment, a holster, or rapid fire requires approval from the Range Master, Assistant Range Master or RSO. It may be a pre-requisite to take one of the classes given at the Sacramento Gun Club to perform these advanced shooting positions.
16. Drawing from the holster is allowed with the use of strong side holsters only. Care must be taken to keep your finger off the trigger at all times when your sights are not on target. Proper techniques are defined by finger and muzzle discipline.
17. Only use the correct ammunition designated for your firearm. Armor piercing/steel core and tracer ammunition is specifically prohibited. Sacramento Gun Club staff understands the difference between steel jacketed and steel core. As a user of our facility you are expected to have the same understanding.
18. Shotguns may be used with slugs.
19. The following procedures must be followed for any firearm or ammunition problems that occur and cannot be resolved in a safe manner by the shooter:

- **Remain in the shooting booth.**
- **Keep the firearm pointed downrange.**
- **Raise your non-shooting hand to signal a Range Safety Officer that you are in need of assistance.**

20. If you observe an unsafe condition, report it to a Range Safety Officer immediately.

21. Upon the command of "CEASE FIRE" stop shooting immediately and engage the safety. Place your firearm on the table or ground pointing downrange and back away from the shooting booth. Do not under any circumstances re-approach the firing line or touch your firearm until the command of "ALL CLEAR" is given.

22. All range commands given by Range Safety Officers must be obeyed immediately and without question. Range commands are non-negotiable.

23. Shooters may collect their personal shot brass within the confines of the shooting booth once they have cleared and locked their firearm in their case. Shooters must remain behind the firing line at all times.

24. RSO's must approve all targets used on the range. Targets deemed inappropriate by RSO are prohibited. Acceptable targets are available for purchase in our Store

25. Wash your hands and face after leaving the range. Be kind to your fellow shooters. Act responsible at all times. Foul language, horseplay or any other unsafe activity will not be tolerated. Shooters may be held financially responsible for range damage caused by improper or negligent use of a firearm.

26. No open toed shoes or sandals.
